Customer will be responsible for the cost of any damage and the full price of the contract. Any damages to the vehicle will be the customer's responsibility. If customers contract is secured with a charge card customer consents to Reserve Party Bus charging Customers account for any additional charges, Reserve Party Bus is not responsible or liable for any damages in the event of unexpected breakdown, accident or severe weather conditions or any other circumstances beyond Reserve Party Bus Service control, and/or delaying arrival of vehicle and/or service. Reserve Party Bus reserves the right to substitute a vehicle or vehicles in place of contracted vehicle if or when necessary (substitutions maybe similar). Neither Reserve Party Bus or its employees are responsible for articles left in the vehicle. No cancellations. Customer Responsible for said contract. Use of unlawful drugs is prohibited. "NO alcohol is allowed to individuals under the age of 21. No smoking. Chauffeur may terminate the carriage for violation of this rule. All vehicles, all changes in this contract must be done in writing. There is no eating in vehicles. Reserve Party Bus isn't liable in the event of a mechanical failure while on charter. Cancellation fees for airport/sedan transfers are half of cost. Limo/Bus/Van cancellations are; \$275 within 1 month, 50% within 3 weeks or 100% within 14 days of reservation.
